USDA Rural Development Business & Cooperative Programs

Rural Development is pleased to announce important changes to the Business & Industry (B&I) Loan Guarantee Program. These changes will better serve rural communities by helping lenders provide loans to businesses and helping to increase employment opportunities for rural residents. These changes include but are not limited to:

- Removal of the U.S. Citizenship requirement for companies wanting to use the B&I loan guarantee to increase employment in rural areas. The applicant company will need to demonstrate the loan funds will remain in the United States and will be invested in the rural community to create and retain employment opportunities.
- Owner subordinated debt may be included as equity provided the debt was established in exchange for cash and the debt remains in the company for the life of the guaranteed loan. This change can help applicants meet the minimum tangible balance sheet equity requirements of the program. Minimum tangible balance sheet equity for an existing business is 10% while a startup business is 20%. All financial statements must be prepared according to Generally Accepted Accounting Principles.
- New Market Tax Credit projects are now be eligible for assistance through the B&I program. Subordinated debt made by the Community Development Entity can be considered as equity into a project. This is another means of helping the business meet the minimum tangible balance sheet equity requirements.
- The guarantee fee can be reduced to 1% of the guaranteed portion for businesses that support value added agriculture; promotes access to healthy foods; or is a high impact business development investment.
- Loan guarantees can for agricultural production can be 50% or \$5MM, whichever is less, of vertically integrated businesses. This is a substantial increase from the previous agricultural production maximum amount of \$1,000,000.

Accelerate MFG / Ohio TechNet Update - December, 2016

As we near the end of the year, I want to provide a quick update on progress for the Accelerate MFG project:

Progress:

- Total participant enrollment in the program has reached 75 individuals, which is 75% of our goal. The grant delivery period will continue until March 31, 2018.
- Students in the SkillsTrac Industrial Maintenance program are progressing as expected. Presently, 20 students have completed a certificate.
- All six of the CAM courses have completed the pilot phase and will be offered in the new hybrid format starting January 2017. The courses are: CAM 1116 - Fundamentals of CNC, CAM 1141 - Shop Floor Calculations, CAM 1109 - Fundamentals of Tooling and Machining, MET 1131 - PC Applications, OPT 1100 - Tooling and Machining Metrology, and CAM 1107 - Principles of Manufacturing.
- To date there have been 44 successful CBE computer aided manufacturing course completions, and CBE students are completing courses an average of 21 days quicker than their traditional student counterparts.
- Accelerate MFG again participated in outreach events such as MFG Day, AMTS, Preble Manufacturing Day and the Xtreme Bots Competition.
- Remember that OMJ can pay for the assessments, training and internships for unemployed (qualifying) individuals seeking employment in high-demand manufacturing careers. Contact us for more information.

Success Stories:

• During the past semester, Accelerate MFG enrolled a student who was working for a local manufacturer and was seeking to improve his career track. Working full time made it virtually impossible for him to participate in a regular class schedule, but he found a perfect solution by enrolling in two Accelerate MFG competency-based courses. These courses provided more flexibility with his schedule, fewer visits to campus, and the ability to accelerate. He was able to test out of those sections where he had competency, spending the majority of his time learning new material and topics. The student was able to compete much of the work online, only coming to campus for open labs to practice hands-on skills. He ended up finishing his first two courses in 8 short weeks, enabling him to enroll in a third Accelerate MFG course. This is a great example of how Accelerate MFG works!

Next Steps:

- Accelerate MFG will begin sustainability planning over the next program year.
- With the recent launch of an enhanced outreach campaign (with the aid of Spectrum Career), our goal continues to be increasing the pipeline of students interested in manufacturing careers and the Accelerate MFG program.
- Sinclair faculty and staff will continue to deliver the courses & certificates over the next four semesters, making additional refinements as needed.
- The flexible delivery aligns well with those currently working in the manufacturing sector.
